It begins with a hybrid kick-off meeting to foster cross-border dialogue and collaboration on peace and security. A youth leadership boot camp in Tirana will equip 35 young people with skills in advocacy, conflict resolution, and democratic engagement. Building on this, youth in Albania will co-develop a policy brief with actionable recommendations for local authorities on promoting peace and inclusion. The project will also support three youth-led community initiatives in both Contracting Parties, addressing local challenges through dialogue, workshops, and inclusive events. Finally, a digital campaign will be designed and launched by 30–40 youth to combat hate speech and disinformation online, using creative content and outreach strategies to reach over 500 young people. Together, these activities create a comprehensive approach to empowering youth participation in decision-making and building more resilient, inclusive communities across the Western Balkans.</p> <p>This action addresses this problem by creating inclusive blogs for youth engagement in local peace and security initiatives. Through a series of activities, such as youth leadership boot camps, policy development workshops, and community-led actions, we empower young people with the skills and knowledge to actively participate in decision-making processes. The project also includes a digital campaign to raise awareness about peace, security, and youth inclusion. The project directly contributes to the Youth, Peace and Security (YPS) agenda by empowering young people to 12 engage in democratic governance and advocate for concrete policy solutions. At the core of the initiative is a mobile outreach tour — a symbolic and practical tool for civic engagement — in which youth teams travel to six municipalities to engage in structured dialogue with local authorities. These proposals will address locally identified issues such as youth participation, participatory budgeting, gender equality, interethnic cooperation, prevention of discrimination and extremism, and improved transparency in local self-governance. If adopted, these solutions could help address key challenges youth face, improve their status in society, and reduce their motivation to migrate. The Democracy Bus will act as a traveling civic space, enabling young people to connect with local public officials, institutions, and communities through youth-led forums, awareness events, and public presentations. One of the municipalities will host a regional mobility exchange, enabling participants from another WB6 Contracting Party to take part, share experiences, and foster intercultural cooperation. We have already established contact with Club Alpbach Montenegro, who have agreed to act as our partner for youth selection and coordination from Montenegro. By building institutional partnerships and producing concrete policy outputs, the project aims to strengthen youth influence in local governance while promoting peacebuilding, democratic values, and interethnic cooperation. It prioritizes the inclusion of marginalized groups and will ensure that at least 60% of all participants are female. It aims to enhance digital safety skills and mental health awareness among youth in Prishtina and Sarajevo. Through a series of interactive workshops, a youth-designed digital safety toolkit, an online exchange session, and a youth-led awareness campaign, the project will empower young people to navigate digital spaces safely and advocate for mental well-being. The project will also produce youth-driven policy recommendations to promote safe and inclusive online environments, which will be presented to local authorities in both cities.</p> <p>The six-month initiative aligns with the RYCO thematic pillars of Participation and Protection, ensuring young people actively engage in shaping safer, more inclusive digital communities. Project addresses the problem in a meaningful and sustainable way by providing youth in Prishtina and Sarajevo with practical skills, tools, and support systems to protect themselves online and maintain mental well-being. Through peer-led workshops, youth will gain digital safety knowledge and learn coping strategies for mental health. The digital safety toolkit, co-created by youth, will serve as a long-term resource for safe online behavior. Regional exchange activities foster mutual understanding and collaboration, promoting lasting relationships. Implemented by HERA in partnership with the Ministry of Social Policy, Demography and Youth, the project will establish or revitalize youth councils in three municipalities, equip marginalized youth with skills in policy-making and advocacy, and create formal cooperation mechanisms between youth, civil society, and public institutions. It strengthens youth capacities through regional training, peer education, and mentorship, enabling them to design local initiatives, engage with municipalities, and influence local action plans (LAPs). Young participants will lead workshops in high schools, co-create grassroots proposals with their communities, and conduct training sessions for local authorities. The project also includes comprehensive mixed-method research on youth discrimination, informing 20 policy recommendations. The final youth-led conference will showcase all outcomes, foster regional dialogue, and promote actionable policies.
